PREAMBLE

Since allegations about our KUSA leaders have been in the limelight, I as The Big Bill, an ordinary student, realised the need to thoroughly assess the people who come to us, as students, to elect them into office.

It is for that need that I created a WhatsApp group, that shall be governed by this constitution in accordance with the constitution of the land and the union.

Name and purpose

There shall be a WhatsApp group, called "The KUSA Debate."

The group shall in particular be an online platform, where students shall interact with the individual aspirants for the upcoming KUSA elections, academic year 2016/2017.

Rules and regulations

- 1. Official debate sessions shall be announced early enough, to give aspirants and their personal assistants enough time to prepare for the same. Absence from a session without apology, and or notice, shall be deemed disrespect to the esteemed comrades who deserve to meet and hear from those who woo and convince them for votes.
- 2. The instructions on how any given particular debate session shall be conducted will always be communicated alongside the announcement of the time of the session and the session itself.
- 3. The interaction shall be in the form of students asking the aspirants questions related to their affairs.
- 4. Aspirants shall be asked to defend themselves on allegations made and/or confirmed or confirmed not about them.
- 5. A case of any aspirant leaving the group shall be considered a signal of disrespect to esteemed comrades who deserve to know the people they are to elect. As such, bloggers will be allowed to write articles, in accordance with the social media policy of Kenyatta University, describing such aspirants to the entire student fraternity as unfit for service.
- 6. Aspirants who shall not be vying and are in the group, and wish to leave, shall notify the administration, who shall notify the bloggers therein to write, and publish articles about these particular aspirants suspending their bids.
- 7. Aspirants are allowed to keep quiet and follow the proceedings, but have a personal assistant nominated and present at all times to answer questions on their behalf. Answers from such personal assistants shall be considered the opinions, convictions, and stand, of the individual aspirants on the subject matter.
- 8. Aspirants are allowed also to have their hecklers or canvassers added to the group to keep on reinforcing their message but in a manner that adheres to the social media policy of Kenyatta University.
- 9. Insults, and statements that may divide, on any basis, shall not be tolerated. Any member found guilty of the same shall be removed from the group at the absolute discretion of the admins! Any aspirant found guilty of the same shall be removed from the group and articles about

them, explaining their uncalled for character, shall be written, published and made so viral that every student shall hear of it, with screenshots, and or audio evidence attached.
